The second **PANELFIT Consortium Meeting** was held in the last week of November at the headquarters of the University of the Basque Country (UPV/EHU) in Bilbao. The event served to evaluate the **status** of the different work-packages and to establish the **next steps** of the project.

This Consortium Meeting divided into **two working days**, assessed the status of some of the deliverables, and other tasks such as the analysis and integration of the National Reports made by PANELFIT's Network of correspondents, which serve to identify the issues that arise in the different countries of the EU, in terms of informed consent, data commercialization, security, cybersecurity and governance, also to find solutions.

The Expert Advisory Board (EAB) meeting was held, and the responsible of the work-packages shared the progress of the tasks and the different activities in open sessions with the other members of the Consortium.

#### "Dark Patterns: born to mislead"

Digital platforms often **trick** users into giving up their personal data or buying particular products. The methods used are especially insidious because they rely (effectively, as various studies have shown) on cognitive biases, or all those "weaknesses" which lead us to make irrational choices: for example, when we want to get rid of a particular distraction (a banner), or we're in a hurry to get something done (sign up to a social network). These "dark patterns" go against European legislation, but authorities are struggling to combat them.
