## **PANELFIT Consortium Meeting and General Assembly**

On 22 April, the PANELFIT **General Assembly** and **Consortium Meeting** was held in an online format, reporting on the amendment derived for the pandemic, and reviewing the work packages and other project activities. One of the issues discussed was the **online version of the Guidelines**, which will focus on 5 technologies and incorporate at least 30 videos to introduce and develop each of the materials.

## Workshop for journalists and the Data Protection's Handbook

On 2 March we held the first of six webinars addressed to journalists on the handling of personal. It was the first occasion in which we presented the working version of the **Practical Handbook for Journalists on Data Protection**, which is now publicly accessible on this page. This tool will be enriched over the coming months with the input and suggestions of journalists themselves. In a spirit of participatory development, the webinar included an open space for questions, from which we will take inspiration to expand the Handbook.

The event was led by **Iñigo De Miguel Beriain**, senior researcher at the University of the Basque Country, and moderated by **Federico Caruso**, a collaborator of OBC Transeuropa.

### **PANELFIT Monthly Chats**

The 16<sup>th</sup> episode of our monthly chat took place on 21 April and will soon be available in the <u>dedicated playlist</u> of our Youtube channel. In the latest episode we hosted **Sophie Kwasny**, Head of the Data Protection Unit of the Council of Europe and responsible for standard-setting (notably the long awaited modernisation exercise of Convention 108) and policy on data protection and privacy.

The next episode will be held on 12 May at 10,30 am CET and will feature another representative from the Council of Europe, **Patrick Penninckx**, who is heading the Information Society Department under the Directorate General Human Rights and the Rule of Law at the Council of Europe. He coordinates standard-setting and cooperation activities in the fields of media, internet governance, data protection and cybercrime.
